### **PROFESSIONAL SERVICES OF FUNERAL DIRECTOR STAFF & OVERHEAD**

**Basic Services of Funeral Director and Staff and Overhead..... \$1,650.00**

To better serve our clients, we are available 24 hours a day 365 days a year. This is the basic fee for the services of our funeral directors and staff to respond to initial requests for service; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; coordinating service plans with cemetery. Also included in these charges are religious ritual washing (Ghusl), shrouding, casket for visitation & transportation to/from All Dulles Area Muslim Society (ADAMS) Funeral Services. This fee includes proportionate overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs and equipment and inventory costs.

**Receiving Remains from Another Funeral Establishment..... \$1,100.00**

Our charges include basic services of funeral and staff.
